### 1. Classes Offered—

### 2. No Stallion Listings or Mare Nominations required.

3. No extra Nomination Fees, just one single payment per class entered.

4. No carry over monies. Entry Fees paid back 100% the year entered.

5. Payment options available from the following schedule—

- ☐ \$100. By June 1st postmark
- ☐ \$200. By July 30th postmark

6. No Entries accepted after July 30th postmark.

7. Office Fee \$10. per horse.

8. If horse is NOT shown in any other approved APHA class the Futurity weekend, a \$25. fee will be applied.

A. Weanlings are exempt from number 8. It does not apply.

9. Weanlings entered with information "Pending" will have until August 1st to submit Registration Papers or proof of papers pending with a work order number, to be eligible. No monies will be given out until Registration Papers are received.

10. Both Horse Owner and Exhibitor must be current members of the Minnesota North Star Paint Horse Club.
11. In all classes, both Regular Registry and Solid Paint Bred Horses will show together.
12. Weanlings— In the event of 10 or more entries per Colts and/or Fillies, the classes will be split Early and Late by birth date.
13. For ALL classes— the following point system will be used. Each horse will receive points according to the position in which it is placed.

1st Place - 120 Points	5th Place - 66 Points	9th Place - 28 Points	13th Place - 6 Points
2nd Place - 105 Points	6th Place - 55 points	10th Place - 21 Points	14th Place - 3 Points
3rd Place - 91 Points	7th Place - 45 Points	11th Place - 15 Points	15th Place - 1 Point
4th Place - 78 Points	8th Place - 36 Points	12th Place - 10 Points	-----

14. Payouts percentages for the North Star Futurities purses will be as follows:

15. There will be NO Refund of fees paid to the North Star Futurities.
16. Substitutions will be allowed ONLY under the following condition:
  - A. Entered horse/foal that is paid in full, expires prior to the Futurity Show. Veterinarian documentation is absolutely necessary or substitute will not be allowed.
17. Insufficient Checks - Any check returned to the North Star Futurities/Minnesota North Star Paint Horse Club will be assessed a \$35.00 fee. Failure to provide full payment of NSF check plus fees within 10 days of notification will result in automatic disqualification— Persons with any outstanding NSF checks plus fees, will not be eligible for any Futurity Classes unless payment in full has been received.
18. It is mandatory for each person earning money to give their Social Security Number or Tax ID to the North Star Futurities before any prize money will be issued.
19. Checks will be issued within 30 days of the Futurity Show.
